### About The Course

The following ate the main features of privatisation:

- (ii) The total management and development of such program should be done by the society.
- (iii) Without depending upon grant/aid each institution will develop its own source of income (Through Fee, Gifts, Charity etc.) for smooth functioning.

#### Transfer:-

All India transfer facilities are also available without any extra charge. #### **Final Examination :-**

Final Examination are held in June and December every year. The certificate and marks-cards are issued to successful students upon qualifying the examination.

#### **Rules and Regulations:**

- 1. Students will have to regularly participate in contact program of the **NISDF**
- 2. All Students must show good behavior and respectful in the class and around institute premises. As regular attendance is an important requirement for successful completion of the course. An application for leave must be submitted well in advance. In case if illness and other unforeseen circumstances the parent/guardian should inform the principal in writing as soon as possible.
- 3. A minimum attendance of 75% of the total teaching session is required during the academic year.
- 4. Notice of such charges will be put on the notice board of the institute that shall be binding on the students.
- 5. Students must fill up the application form in their own handwriting.
- 6. Tuition fee has to be deposited by the 5th of every month. In case of the Centre having more than one Section, Centre in-charge will decide different dates for submitting the fees. But in no case, payment of fees should be delayed beyond the 10th of every month.
- 7. In case of default, the date of submission of the late fees would be 20th of every month and the students has to pay Rs. 50/- as a late fee charge.
- 8. A student will have to pay tuition fee for all the 12 month of the calender year.
- 9. Fee once deposited will not be refunded in any case.
- 10. An identity card is issued to every student who is expected to carry it on his/her procession whenever coming to the institute.
